

University of Washington Copyright Permission

The University of Washington, a public institution of higher education and agency of the State of Washington, with offices at 4545 Roosevelt Way NE, Suite 400, Seattle, Washington 98105 ("UW") grants Clinical Data Interchange Standards Consortium ("Grantee") permission to use various materials developed at the National Alzheimer's Coordinating Center ("NACC"), as shown in the accompanying Attachment (the "Work").

Grantee is proposing to develop a documentation package that includes Controlled Terminology, annotated Case Report Forms, Foundational standards mappings, and any other supplement relevant to the developed Therapeutic Area User Guide (collectively, the "CDISC Package"). Grantee is also proposing to maintain and distribute the CDISC Package for use by third parties in their clinical trials. Grantee further requests to annotate the Work in such a way as to map the Work into the CDISC-standard format. To be clear, Grantee is not requesting permission to modify the substance of the Work or otherwise alter the substance of the Work in any way ("Purpose").

1. UW hereby grants to Grantee, and Grantee accepts, the non-exclusive, non-transferable, fully paid up, royalty free, right to reproduce and distribute the Work, to the extent UW has rights, for the Purpose in all printed and electronic formats worldwide.
2. UW reserves all rights not expressly granted by this Permission.
3. Grantee agrees the Work is the intellectual property of UW and Grantee shall retain all UW copyright and attribution statements, notices, credits, and acknowledgements in any use of the Work. 6. The Work is provided "AS IS," with UW under no obligation to provide accompanying services, updates, or support. Grantee is the exclusive bearer of any risk associated with use of the Work.
7. UW EXPRESSLY DISCLAIMS ANY AND ALL WARRANTIES REGARDING THE WORK, WHETHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES PERTAINING TO MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR WARRANTIES OF NONINFRINGEMENT.
